## **Registration and Membership**

Conference registration may be limited by the size of the venue. Only registrants with name tags will be admitted to the conference hall. Advanced registration is available online until April 25 at www.KansABA.org or through the USPS with an April 20 or earlier postmark sent to the Kansas Association for Behavior Analysis, Department of Applied Behavioral Science, University of Kansas, 1000 Sunnyside Avenue, Lawrence, KS 66045. Registration automatically includes annual conference-to-conference KansABA membership; admission to the conference's Career and Education Fair (see below); snacks and drinks throughout the conference; box lunches; and an evening reception. Non-registrants may become KansABA members at half the cost of conference registration in the membership categories described below. Memberships only should be sent directly to KansABA at the address above.

Pre-registration for KansABA Full Members is \$50. Full members meet the requirements for full membership in the Association for Behavior Analysis International (ABAI). Only they have KansABA voting rights on KansABA policies and procedures. Pre-registration for Affiliate Members is \$40. Affiliate Members are citizens of the State of Kansas and Kansas City metropolitan area who have an interest in behavior analysis in Kansas. Pre- registration for Adjunct Members is \$30. Adjunct Members are citizens in other states and countries who have an interest in behavior analysis in Kansas. Pre-registration for Student Members is \$20. Student Members meet the requirements for student membership in ABAI. On-site registration begins at 7:30am and closes at 1:30pm. The registration rates are an additional \$5 in each category. Cash, checks, and credit cards are accepted.

KansABA members may apply for reduced-rate "chapter/adjunct" membership status in ABAI. It provides ABAI member benefits, but not a subscription to *The Behavior Analyst* or voting privileges. Among the benefits of ABAI chapter/adjunct membership are the ABAI conferences; continuing education at the conferences or through ABAI's online Learning Center; and access to job postings, liability insurance, and a practitioner journal.

#### **Student Poster Session**

KansABA will host a poster session for undergraduate or graduate student research and scholarship in basic, applied, or translational research or on conceptual issues in behavior analysis. Students submit a title page (e.g., title, authors) and a 250-word abstract for their posters to posters@kansaba.org by April 1. They will be notified of their acceptance by April 8. The content of the abstracts and posters must adhere to the ethical standards of behavior analysts (see J. S. Bailey and M. Burch [2011]. *Ethics for Behavior Analysts* [2nd ed.]. New York: Routledge). The presenting author must register for the conference. The posters will be set up between 9:00 am and 4:00 pm in the West Lobby or West Meeting Room.

## Behavior Analysis Certification Board Continuing Education Units and Certificates of Attendance

Behavior Analysis Certification Board (BACB) continuing education units (aka CEUs) will be provided. The CEUs are \$15.00 per session or \$60.00 for the full conference's if purchased in advance

by April 25 at www.KansABA.org or through the USPS with an April 20 or earlier postmark sent to the Kansas Association for Behavior Analysis, Department of Applied Behavioral Science, University of Kansas, 1000 Sunnyside Avenue, Lawrence, KS 66045. They are \$20.00 a session or \$70.00 for the conference's five sessions if purchased on site. Credit cards, checks, and cash are accepted. Certificates of attendance for the full conference will be available gratis.
